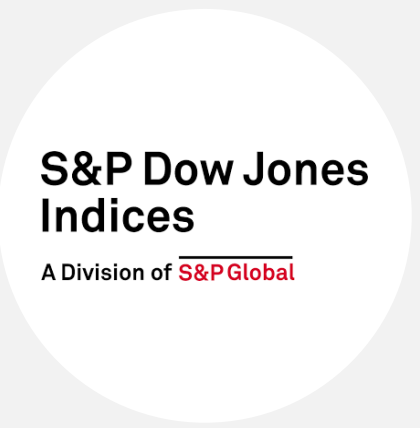
GULF BANK INDEX LANDSCAPE

SINCE SEP 2018

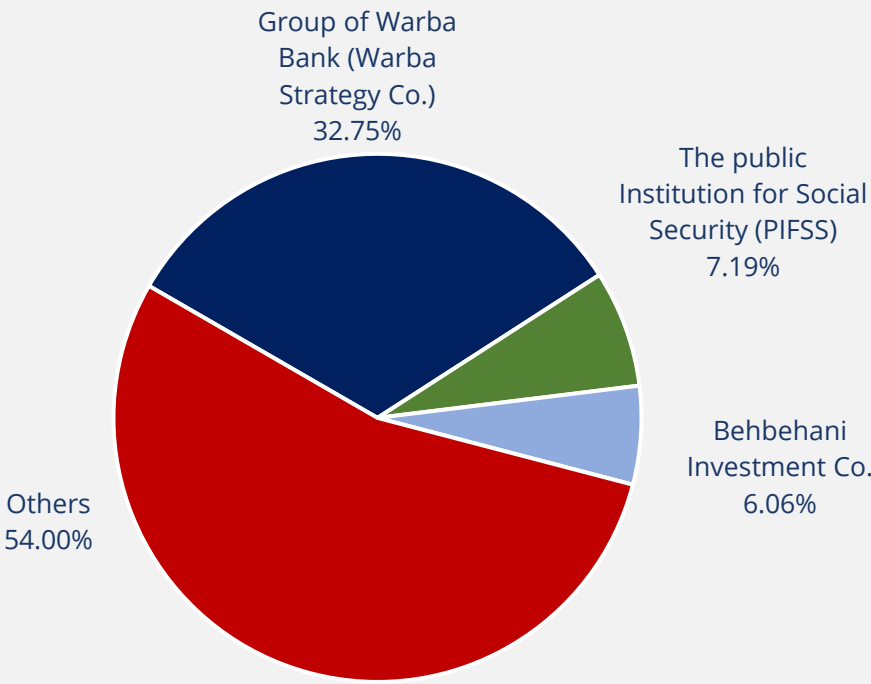


S&P DJI EMERGING

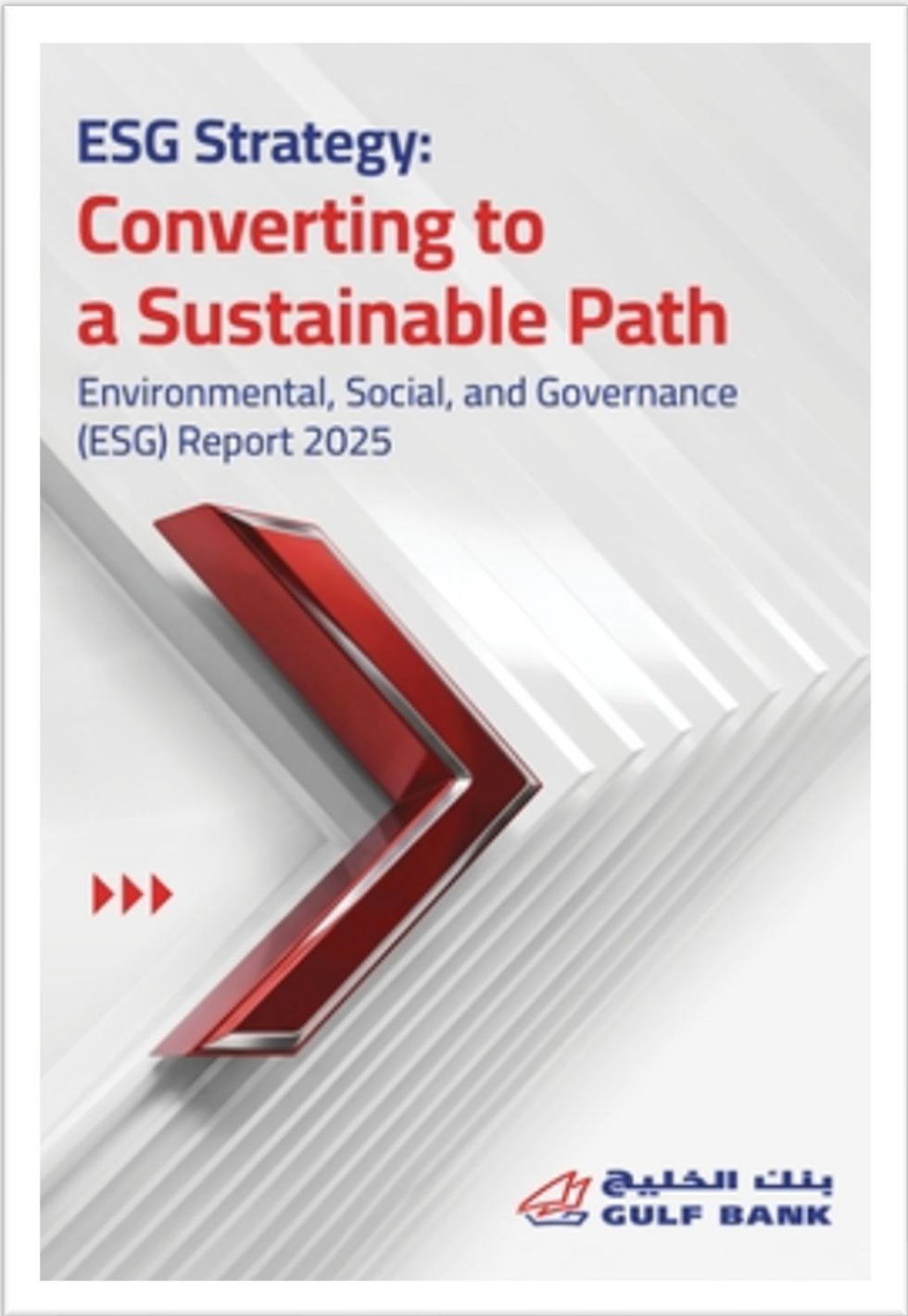
