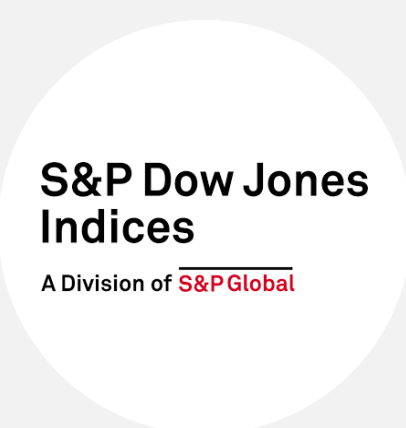
GULF BANK INDEX LANDSCAPE

FTSE RUSSELL EMERGING MARKETS INDEX SINCE SEP 2018

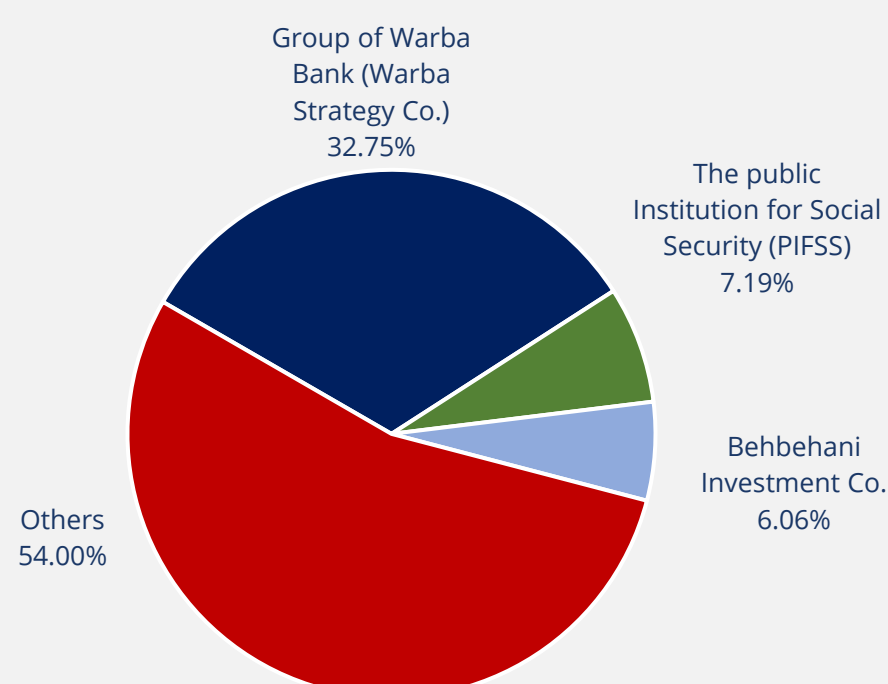


S&P DJI EMERGING MARKET INDEX SINCE DEC 2018

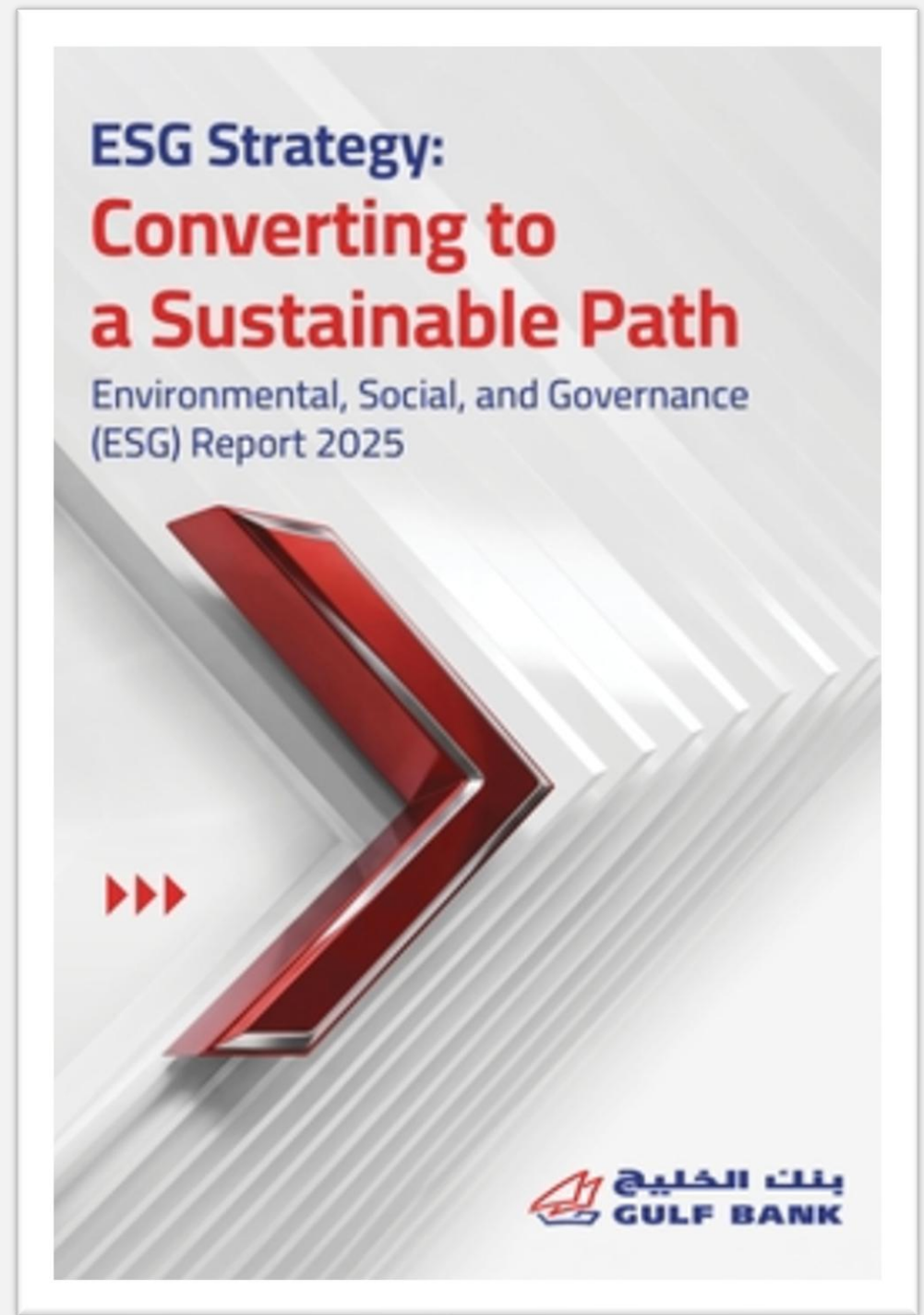
